BREAKING THE SILENCE WITH WENDY MENDEZ

On June 4th, alongside human rights activist and popular educator Wendy Mendez, the Halifax WAC participated in a speaking tour presented by the Maritimes-Guatemala Breaking the Silence Network. Wendy is the daughter of Luz Haydee Mendez Calderon, who was forcibly disappeared by the Guatemalan Army in 1984. She spoke about her experience bringing her mother's case before the national courts of Guatemala and the barriers to justice for the her and other plaintiffs.

WAC volunteer lawyer, Katrin MacPhee, spoke at the event about the issue of access to justice, the importance of fair processes, and the administrative barriers currently preventing workers from making effective use of Nova Scotia's human rights tribunal.

MEET THE WAC: EMMA LUTZ

Emma is a second-year law student at Dalhousie University. She comes to us after working extensively with the Dalhousie Legal Aid Service's Tenants' Rights Project. While working with tenants in Nova Scotia, she saw how low-income and marginalized people often face dual barriers in their access to both tenancy and employment justice. This inspired her to spend her summer with the Halifax WAC assisting workers in their struggles against abusive and exploitative employers.

"Since beginning at the WAC, I have witnessed first-hand how essential their services are in Nova Scotia given the shocking lack of support for workers, inadequate protections, and inefficient legal and administrative systems," says Emma.
