

WORKING WITH AN INVISIBLE DISABILITY

"People with disabilities are often doubted and looked at negatively by employers. When my employer doubted and then refused to accommodate my invisible disability, despite excessive medical documentation, I was at a loss and didn't know where to turn. As a nonunionized worker, I had no support.

As my illness worsened, completing paperwork and meeting legal deadlines was tough. Luckily, I came across the Halifax WAC. They listened to my concerns and helped me advocate for myself. Thanks to them, I submitted my human rights complaint on time. I hope to see justice soon."
